

Student Exchange Agreement

between

the Universidad Nacional de Córdoba, Argentina

Haya de la Torre S/N, Pabellón Argentina, second floor, Ciudad Universitaria, Córdoba, Argentina

and

the Universität Regensburg, Germany

Universitätsstr. 31 (93053) Regensburg, Germany

The Universidad Nacional de Córdoba (UNC), in Argentina, and the Universität Regensburg (UR), in Germany, agree to implement a Student Exchange Agreement under the following terms:

Article 1

The Exchange Agreement will be administered by the International Relations Office at UNC and by the International Office at UR.

Article 2

Each University could send up to four undergraduate students per year. In principle, one of these places is reserved for the areas of German Language and Literature, German as a Foreign Language, American and British Studies and Romanistic Studies. Students exceeding the aforementioned number will be admitted as undergraduate students from foreign universities without an agreement and will not be covered by the terms of this agreement.

Article 3

Enrolment at the Host University will be of one semester and could be extended to one year at a maximum without altering the number of exchange students agreed in Article 2.





Article 4

Exchange candidates should have completed a minimum of two semesters at the Home University; they should be able to prove good academic standing and foreign language proficiency as required by the Host University. Exchange students from the UNC shall provide proof of English or German B2 level according to the Common European Framework of Reference at the moment of the application. Exchange students from UR shall provide proof of Spanish B2 level.

UR students must demonstrate a B2 level of Spanish. Only CELU, DELE, DAAD, ACTFL exams with the indicated level will be accepted. If the student does not have any of these certificates, he/she can bring a certificate or official letter issued by his/her home university confirming his/her knowledge of Spanish. This will imply a provisional admission, and the student must subsequently certify his/her level of Spanish in a definitive manner by means of one of the following options:

- Option 1: Spanish and Latin American Culture Programme (PECLA, UNC). Semester course of Integrated Skills Development in Spanish.
- Option 2: CELU exam. They will be able to take the CELU exam at the beginning of each semester at UNC.

Although students nominated by the Home University will be generally admitted by the Host University, the latter holds the right to a final decision regarding students' admission.

Article 5

Each University will provide a list of nominated exchange students as well as the documentation required for each call. Each University will inform the counterparty the final decision about admission of the students according to deadlines previously agreed.

Article 6





The Host University will provide incoming exchange students with information and orientation needed to comply with migration proceedings. It is the responsibility of each student to comply with migration regulations required by the Host University.

Article 7

Once UNC students are admitted by the Host University, they will be referred to as exchange student. Once students are admitted by the UNC, they will be referred to as *estudiante regular internacional*. In both cases, students will comply with the regulations of the Host University.

Article 8

Exchange students can enrol into any of the undergraduate courses* offered by the Host University. *courses included in undergraduate degree programs with exception of those with prerequisites and those belonging to Medicine.

Article 9

Every academic credit or grade obtained during the exchange period will be transferred to the Home University in accordance with its own regulations.

Article 10

Both universities shall assist students on academic and administrative matters.

Article 11

Each student shall pay any applicable fee required by the Home University, but will be exempt from them at the Host University. The Universität Regensburg is raising a mandatory student service fee from all its students. The fee is not a tuition fee and therefore cannot be waived.

Article 12

Exchange students shall pay all living and travel costs, fees for visa services, as well as costs for non-degree and language courses.





Article 13

Exchange students shall provide proof of life, health, accident and repatriation insurance. Students with destination UR need to effect German statutory health insurance.

Article 14

This agreement shall commence on the date of its signing by both Universities and shall continue thereafter for five (5) years. It will be renewed automatically for the same period of 5 years unless one of the parties objects. This objection must be announced at least 6 months in advance and in writing.

Each University shall be able to terminate this agreement upon written notice no less than six months prior to the beginning of the next academic semester.

Article 15

The resolution of possible disputes arising from the interpretation and execution of this agreement will be entrusted to an arbitrating body composed of one member appointed by each of the contracting Universities, and of a member chosen by mutual agreement.
